THIS PRODUCT CONTAINS ETHYLBENZENE.

A study conducted by the National Toxicology Program states that lifetime inhalation exposure of rats and mice to high concentrations of ethylbenzene (750 ppm) resulted in increases in certain types of cancer, including kidney tumors in rats and lung and liver tumors in mice. Incidences of testicular adenoma were increased along with increased incidences of thyroid effects in rats at 750 ppm; pituitary effects were observed in female mice at 250 ppm. These effects were not observed in animals exposed to lower concentrations of ethylbenzene (75 ppm). The study does not address the relevance of these results to humans.

Formaldehyde has oral (rat) and dermal (rabbit) LD50 values of 800 mg/kg and 270 mg/kg, respectively. The LC50 following a 4-hour inhalation exposure to rats is 250-478 ppm. Irritation of the nose and throat has been observed in people exposed to formaldehyde vapor levels in excess of 1 ppm. Normal breathing may be seriously impaired at levels above 10 ppm and serious lung damage can occur at levels exceeding 50 ppm. No pulmonary sensitization has been demonstrated in laboratory animal studies. Formaldehyde solutions can cause severe eye and moderate skin irritation. Repeated skin exposure to solutions of 2% or more formaldehyde has caused allergic skin reactions. Formaldehyde was found to be weakly mutagenic in a number of in vitro genotoxicity tests, but inactive in vivo. Formaldehyde did not cause birth defects in rats inhaling concentrations up to 10 ppm. Lifetime inhalation of formaldehyde vapor at concentrations above 5 ppm for 6 hours per day caused nasal tumors in laboratory animals. Epidemiology studies have failed to link cancer in humans with occupational exposure to formaldehyde. Formaldehyde is a chemical known to the State of California to cause cancer.
